Loughgraney

Loughgraney is a collective name for communities in east County Clare surrounding the lake, Lough Graney. It is a very rural area with all the aspects of a traditional rural life. The main population clusters are Dromindoora, Caher and Flagmount. The closest commercial centre is Scariff, which is about 14km from Caher. But as the area is located close to the Galway border, there is also a significant draw to Gort, Co. Galway which is approximately 20km (from Caher). Ennis, Clare's County Town, is 37km from Caher, a drive of about 40 minutes. The M

Loughgraney is an area of great scenic beauty and its greatest natural asset is the Lough itself. There are great opportunities for outdoor activities such as walking, swimming and water sports.


The task of this process was to allow residents to acknowledge the strengths of the community and to identify aspects which could be improved upon.





Community Profile

Loughgraney residents are situated mainly in the Electoral Divisions of Killanena (Dromindoora), Derrynagittagh (Caher) and Corlea / Cahermurphy (Flagmount).



Collating census data for Loughgraney is complicated by the fact that the community resides in at least three Electoral Divisions.

In 2016 the Census returned the following data for each ED:


Killanena population was 257, of which Males numbered 132 and Females were 125. The total housing stock was 127, of which vacant households (excluding holiday homes) numbered 20.

Derrynagittagh population was 137, of which Males numbered 71 and Females were 66. The total housing stock was 68, of which vacant households (excluding holiday homes) numbered 8.

Corlea/Cahermurphy population was 170, of which Males numbered 83 and Females were 87. The total housing stock was 103, of which vacant households (excluding holiday homes) numbered 17.






The population in Killanena was almost the same in 2016 as it was in 2011















 The population of Killanena ED is almost entirely Irish, with a small number of UK nationals and very few other nationalities.




• There almost no ethnic diversity in Killanena ED






• There is no consistent trend in number of different sized families between 2011 and 2016.




- There were 5 fewer private households in Killanena ED in 2016 than there were in 2011.

- There were no residents in local authority or social housing in 2016




• There were 20 vacant dwellings in Killanena ED in 2016.






Population 15 years and over by principal economic status




 A significant portion of the population in Killanena ED is retired, this proportion has grown since 2011.



• No significant educational attainment trends in Killanena ED between 2011 and 2016.










Persons with a disability by sex

Carers by sex



 The number of people employed in the agriculture, forestry and fishing sector has reduced significantly in Killanena ED between 2011 and 2016.










Loughgraney Community Development Planning Process

Following an initial expression of interest by Loughgraney Community Development Association (LCDA) to Clare Local Development Company, a four-phase process was undertaken to inform this plan:

- An Orientation Phase: This phase involved the establishment of the planning group to lead and project-manage the planning process in Loughgraney. Orientation was provided on how to conduct an evidence-informed planning process while materials and information were also provided to the planning group to support the process.
- 2) An Information Gathering Phase: The planning group implemented a broad-based consultation process during Phase 2. A survey was developed (see Appendix 1) to enable residents to identify strengths, needs, interests and concerns from their experiences of living in Loughgraney, and to identify priority projects that they'd like addressed in the emerging community plan. A total of 74 individuals from across the life cycle responded to the survey as outlined below:



The gender breakdown of respondents was 67% female and 33% male.

- 3) Analysis of Information and Action Planning Phase: Phase 3 required the planning group to examine the information gathered through the community consultation, identify priority needs and select priority actions based on both need and the ability of the community to implement the actions.
- 4) Writing Phase: Phase 4 involved the preparation, agreement and finalisation of this document as the core output of the planning process.



Survey Results & Prioritised Actions
